## STOUGHTON UTILITIES PRIVATE LEAD SERVICE LINE (LSL) REPLACEMENT PROJECT PREQUALIFIED PLUMBERS LIST

Plumbers included on this list responded to our request for qualifications (RFQ) to work with Stoughton homeowners to complete the replacement of private LSLs.

To be included on this list, companies must meet certain criteria that include:

- Plumbers license in good standing;
- Experience performing such work in a satisfactory manner that meets all federal, state, and local building and plumbing codes;
- Compliance with Use of American Iron and Steel provisions and requirements;
- Adherence to working safely and according to OSHA and other generally accepted safety standards and practices;
- Willingness to hire and make good faith efforts to hire subcontractors according to the Disadvantaged Business Enterprise solicitation provisions.

The Wisconsin Department of Natural Resources (WDNR) may make funds available to Stoughton Utilities to replace the privately-owned portion of a LSL serving a single-family home, multifamily home, K-12 school, or licensed daycare facility. In order for Stoughton homeowners to be eligible for the potential reimbursement of the private LSL replacement costs, a plumber that is listed below <u>must</u> perform the work. Stoughton Utilities highly recommends that homeowners obtain two or three quotes for private LSL replacement work before entering directly into an agreement with a plumber on this list. Once the work is completed, an application for reimbursement will need to be submitted to Stoughton Utilities and signed by the property owner and authorized representative from the plumber listed below. These potential funds can be used <u>only</u> for private LSL replacement, which is defined as the replacement of existing LSL between the curb stop and water meter within a structure.
